



San Diego Book Arts Second National Juried Exhibition Call for Entries

Accepted works received: September 5, 2008
Opening Reception: September 20, 2008
Exhibition: September 20 – October 31

Submission Requirements: Artists must live or work within the USA. Up to three works may be entered, 3 images per work, a maximum of 9 images per artist. Submission must include, entry form, images, and fee.

Media: All structures of artist's book, unique or limited edition. Due to case size and exhibition space, work should not exceed 30 inches in any dimension.

Fee per Artist: \$15 for San Diego Book Arts members, \$25 for non-members.

Images: Digital images in JPEG (.jpg) format on a compact disk (CD), which will not be returned, are preferred. DVD discs will not be accepted. One full and up to two detail images may be submitted for each entry. Images should be approximately 1200 x 1800 pixels. Images should be labeled with the first word of the title and whether full or detail, e.g., for a book titled "Unplanned Obsolescence" the images should be labeled unplannedfull.jpg, unplanneddetail1.jpg and unplanneddetail2.jpg. CDs should be labeled with artist name and title(s) of the art work and in protective cases.

While the submission of jpeg images is strongly encouraged, slides are acceptable. Label each slide with image number, artist's name, and correct orientation of work. Note: if submitting slides, include a Self-Addressed Stamped Envelope for return of slides (slide return not guaranteed without SASE).

If accepted, artist is responsible for cost of shipping to and from exhibition.
